









#### **Bolts**

- Type-either resin anchor or shield anchor bolts
- Size-5/8 in.(M16)
- Minimum Length-5.9 in.(150mm)
- Strength-high tensile(minimum ISO property class 8.8)

#### Washers

- Type-flat, steel(as per DIN7349 or equivalent)
- Size-5/8 in.(M16)
- Outer diameter-no greater than 1.58 in.(40mm)
- Minimum thickness-0.2in.(6mm)
